We are a customer based program. We acquire customers through an innovative marketing concept of the “**one bottle approach**”. DailyGold is a premium liquid multi-vitamin & mineral supplement. Priced at \$48.99 + shipping. Comes with a 90-day money back guarantee.

Our product is distributed by Independent Distributor(s). In order to apply to become an EmzaGold Distributor, you must visit the website of the person that shared EmzaGold and sign up online.

Distributors enjoy the many benefits of participation in the EmzaGold program. EmzaGold provides the Distributor easy entry into the program, there are no start up fees, no website hosting fees, no back-office fees, and no distributor kit fees. EmzaGold has designed one of the most lucrative and unique compensation plans in the industry with an exclusive feature called the “**5 and 10 Plan**”.

The “**5 and 10 Plan**” allows Distributors to accomplish “2 Goals” in progression, as outlined below:

By enrolling 5 Customers and/or Distributors you earn a total of **\$100**, and will now qualify to get your one month supply of DailyGold for **FREE** (just pay shipping).
